As you may know, the sale of 1008 Pandora Ave. (former St. Andrew's Elementary School site) is contingent upon the City of Victoria's approval of the rezoning and redevelopment application. The Public Hearing is scheduled for **Thursday, August 27, 2015 at 7 pm at the Victoria City Hall**. At this final hearing, members of the public are invited to speak on the proposed redevelopment to the Mayor and Council who will then decide whether or not the redevelopment is approved.

Given the importance of the redevelopment application and the subsequent sale of the property to the overall capital and seismic upgrades of our Catholic Schools in Victoria, we would like to ensure that there is fair and balanced representation from members of the public at the Public Hearing. There is a group of local residents who are actively opposing this redevelopment and they are soliciting people to speak against this proposal. We would like to invite supporters (and those with neutral opinions) to attend in order to provide the Mayor and Council with a more balanced and positive view of the potential improvements that this development will bring to the area.
